

Kai Tak Cruise Terminal Car Park

TERMS AND CONDITIONS OF USE

OPENING HOURS ARE: 7AM TO 11PM

1. The car park is open daily from 7:00am to 11:00pm.
3. Parking spaces cannot be used for storage or be blocked off in any manner.
4. Vehicles cannot be left abandoned in the parking lot.
5. Motorists are prohibited from causing any fire threat, nuisance, damage or inconvenience to Worldwide Cruise Terminals (Hong Kong) Limited or any other motorist inside the parking lot.
6. No vehicle maintenance is allowed inside the parking lot.
7. No unauthorized activity, smoking, gambling, loitering, gathering, photography or videography is allowed inside the parking lot.
8. Vehicles will be clamped if they are illegally parked in any of the reserved, disabled or unauthorized locations inside the parking lot. Unlocking fee is \$320.
9. Users must be held accountable for the sounding of the car's alarm system. The car alarm cannot continue to sound for more than 5 minutes under any circumstances.
10. The user of the parking space cannot install barriers, chains or make unauthorized changes or additions to the parking space.
11. Unauthorized users are not allowed to wash their vehicles inside the parking lot.
12. It is prohibited to use fire-fighting facilities to clean or wash vehicles.
13. If the user of the parking space causes structural damage to any fixture of the building, then the user will be liable for full compensation of the damage caused to Worldwide Cruise Terminals (Hong Kong) Limited.
14. In the event of a lost parking ticket, octopus or credit card used upon entry, the amount charged will be calculated from the opening time of the car park on that particular date.
15. Worldwide Cruise Terminals (Hong Kong) Limited is not liable for any stolen properties, damaged vehicle parts, or any bodily harm or injury sustained in the parking lot area.
16. Motorists must park their cars within the designated lines of the parking space. While parked, the vehicle must not block any other vehicle.
17. Each parking space can only fit one vehicle.
18. Motorists are advised to comply with all traffic signs, rules and regulations at all times.
19. Users shall pay the parking fee in accordance to the charges of that particular day.
20. Disabled parking spaces are reserved for Disabled Person's Parking Permit Holders only. A valid parking permit must be suspended from the rearview mirror or be displayed visibly on the dashboard of the parked vehicle.
21. Disabled Person's Parking Permit Holders shall have no priority over other car park users when entering the car park. Disabled Person's Parking Permit Holders are required to queue up along with other car park users when there's a queue.
22. All loading and unloading light trucks or lorries must park in the designated loading spaces.
23. All motorcyclists must park in the designated motorcycle parking spaces.
24. Motorists must- switch off their engines when parked inside the parking lot.
25. Motorists must abide by the terms and conditions outlined here. Worldwide Cruise Terminals (Hong Kong) reserve the right to change any of the above terms and conditions including, but not limited to parking fees and parking concessions without making any prior announcement.
26. Worldwide Cruise Terminals (Hong Kong) Limited reserves the right to lock or remove any vehicle from the parking area, without prior notice, and at the vehicle owner's expense, if any of the above mentioned terms and conditions are breached.
